- governing the Baekgaard Trust.
- (2) The reporting person disclaims beneficial ownership of these shares.
- (3) Following the reporting person's receipt of the 500,000 share distribution from the Baekgaard Trust, the reporting person immediately transferred the shares to the Thomas F. Byrne, II 2017 Grantor Retained Annuity Trust #1, of which the reporting person is the sole trustee and annuitant.
