



Vesting of Restricted Stock Units

San Diego, California and Sydney, Australia (Thursday, 8 June 2017, AEST) – REVA Medical, Inc. (ASX: RVA) (“REVA” or the “Company”) announces that a total of 47,800 shares of common stock (equivalent to 478,000 CDIs) have been issued to the Company’s non-executive directors following vesting of 47,800 Restricted Stock Units (“RSUs”). Following approval by the Company’s stockholders, the RSUs had been awarded under the Company’s Amended and Restated 2010 Equity Incentive Plan. Details of the stock issuances are provided in the attached Appendix 3B.

Following the RSU vesting, there remain 6,544,292 options to purchase shares of common stock and 911,000 restricted stock units subject to vesting under the Company’s equity incentive plans.

About REVA

REVA is a medical device company located in San Diego, California, USA, that has developed a proprietary bioresorbable scaffold, as an alternative to metal stents, to treat coronary artery disease. Scaffolds provide restoration of blood flow, support the artery through the healing process, then disappear (or “resorb”) from the body over a period of time. This resorption allows the return of natural movement and function of the artery, a result not attainable with permanent metal stents. The Company’s *Fantom*[®] scaffold has been designed to offer an ideal balance of thinness and strength, with distinct ease-of-use features including complete scaffold visibility under x-ray, expansion with one continuous inflation, and no procedural time limitations.
