Mr. Stockman disclaims beneficial ownership of these securities, except to the extent of his pecuniary interest therein.
- (3) Mr. Stockman is a trustee of the Kenneth Rainin Administrative Trust U/D/T 3/29/90 and has voting and dispositive power with respect to these shares. Mr. Stockman disclaims beneficial ownership except to the extent of his pecuniary interest therein.
- (4) The option shares shall vest in four equal quarterly installments, with the first installment on October 9, 2017.
