



Exercises of Stock Options

San Diego, California and Sydney, Australia (Wednesday, 28 December 2016 AEDT) – REVA Medical, Inc. (ASX: RVA) (“REVA” or the “Company”) announces the issuance of 83,658 shares of common stock (equivalent to 836,580 CDIs) upon the exercises of employee stock options. The options had been issued under the Company’s Amended and Restated 2010 Equity Incentive Plan (the “Plan”). Details of the exercises are provided in the attached Appendix 3B.

In addition to the exercises, a total of 87,008 options were retired from the Plan on 21 December 2016 and a total of 75,000 options were forfeited on 26 December 2016. Following this activity, there are outstanding options to purchase a total of 6,128,192 shares of common stock (equivalent to 61,281,920 CDIs) and a total of 754,000 RSUs (equivalent to 7,540,000 CDIs) outstanding and subject to vesting under the Company’s equity incentive plans.

About REVA

REVA is a clinical stage medical device company located in San Diego, California, USA, that is working to commercialize its proprietary bioresorbable scaffolds, as an alternative to metal stents, to treat coronary artery disease. Scaffolds provide restoration of blood flow, support the artery through the healing process, then disappear (or “resorb”) from the body over a period of time. This resorption allows the return of natural movement and function of the artery, a result not attainable with permanent metal stents. The Company’s *Fantom*[®] scaffold has been designed to offer an ideal balance of thinness and strength, with distinct ease-of-use features including complete scaffold visibility under x-ray, expansion with one continuous inflation, and no procedural time limitations. REVA will require regulatory approval before it can commercialize *Fantom* or any other product.
