- (2) Includes 35,491 RSUs and DERs relating to RSUs, adjusted to reflect the cumulative effect of fractional shares, 4,120 performance shares earned but not vested with respect to TSR performance shares granted on 9/8/2014, 1,050 performance shares earned but not vested with respect to performance shares granted on 1/15/2015, and DERs related thereto.
