Units vest 50% on the second anniversary of the grant date and 50% on the fourth anniversary of the grant date, and will settle in shares of common stock. Dividend equivalent rights (DERs) will accrue.
- (2) Includes 76,465 RSUs and DERs relating to RSUs, adjusted to reflect the cumulative effect of fractional shares, 6,307 performance shares earned but not vested with respect to performance shares granted on 1/15/2015, 13,973 performance shares earned but not vested with respect to TSR performance shares granted on 9/8/2015, and DERs related thereto.
