The reporting persons on behalf of which this Amendment No. 2 is being filed have executed a restated Joint Filing Agreement reflecting the removal of EverPoint as a reporting person with respect to this Amendment No. 2 and any subsequent amendments thereto, attached as Exhibit 99.1 hereto.
