## **OpTic Gaming Takes the Crown at Call of Duty World League Dallas Open Presented by PlayStation®4**

### ***The Top Eight Teams Took Home Their Share of the \$200,000 Prize Pool After a Hard-Fought Three-Day Competition***

SANTA MONICA, Calif.--(BUSINESS WIRE)-- The CWL Dallas Open, hosted by Major League Gaming Corp., has concluded after a nail-biting competition with OpTic Gaming claiming the top place finish. Teams eUnited, FaZe Clan and Splyce rounded out the top four spots at the end of the three-day tournament at the Fort Worth Convention Center in Fort Worth, TX. OpTic Gaming claimed the largest piece of the prize pool, while securing their spot in the inaugural Call of Duty World League Presented by PlayStation®4, Global Pro League, beginning April 20.
