Explanation of Responses:

- Due to an inadvertent error by the reporting owner, the total number of shares of Common Stock of the Issuer owned prior to this transaction was incorrectly reported. As a result, the amount of securities beneficially owned by the reporting owner following the April 2, 2007 transaction was 5,000 shares greater than reported. This error, when adjusted for the stock dividends paid by the Issuer on September 20, 2012 and September 4, 2013, and the two-for-one stock split of the Issuer's Common Stock on February 2, 2016, is presently equal to 12,080 shares.
- The ownership form of these shares was previously reported as Direct, however, the shares were actually purchased through the reporting owner's IRA.
