Any unvested options at the time of a change in control event vest immediately prior to the effective date of the event if certain conditions are met.
- (3) 21,390 options are fully vested and exercisable. The remaining options vest and become exercisable ratably on June 30, 2011 and 2012 subject to the achievement of cumulative cash flow performance goals and to the reporting person's continued employment, with the opportunity to "catch up" on missed goals if certain performance conditions are satisfied. Any unvested options at the time of a change in control event vest immediately prior to the effective date of the event if certain conditions are met.
