**Item 5.07 Submission of Matters to a Vote of Security Holders**

On June 6, 2017, OFS Capital Corporation, a Delaware corporation (the “Company”), held its 2017 Annual Meeting of Stockholders (the “Annual Meeting”). There were present at the Annual Meeting in person or by proxy stockholders holding an aggregate of 11,275,021 shares of the Company’s common stock, out of a total number of 13,203,216 shares of the Company’s common stock issued and outstanding and entitled to vote at the Annual Meeting. The following matters were submitted at the Annual Meeting to the Company’s stockholders for consideration:

1. The election of two Class II directors who will serve for three years, or until their successors are elected and qualified; and
2. The ratification of the selection by the Audit Committee of the Company’s Board of Directors of BDO USA, LLP as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2017.

Robert J. Cresci and Bilal Rashid were elected to serve as Class II Directors until the 2020 annual meeting of stockholders, or until their successors are elected and qualified, and the appointment of BDO USA, LLP as the independent registered public accounting firm for the Company for the fiscal year ending December 31, 2017 was ratified.
