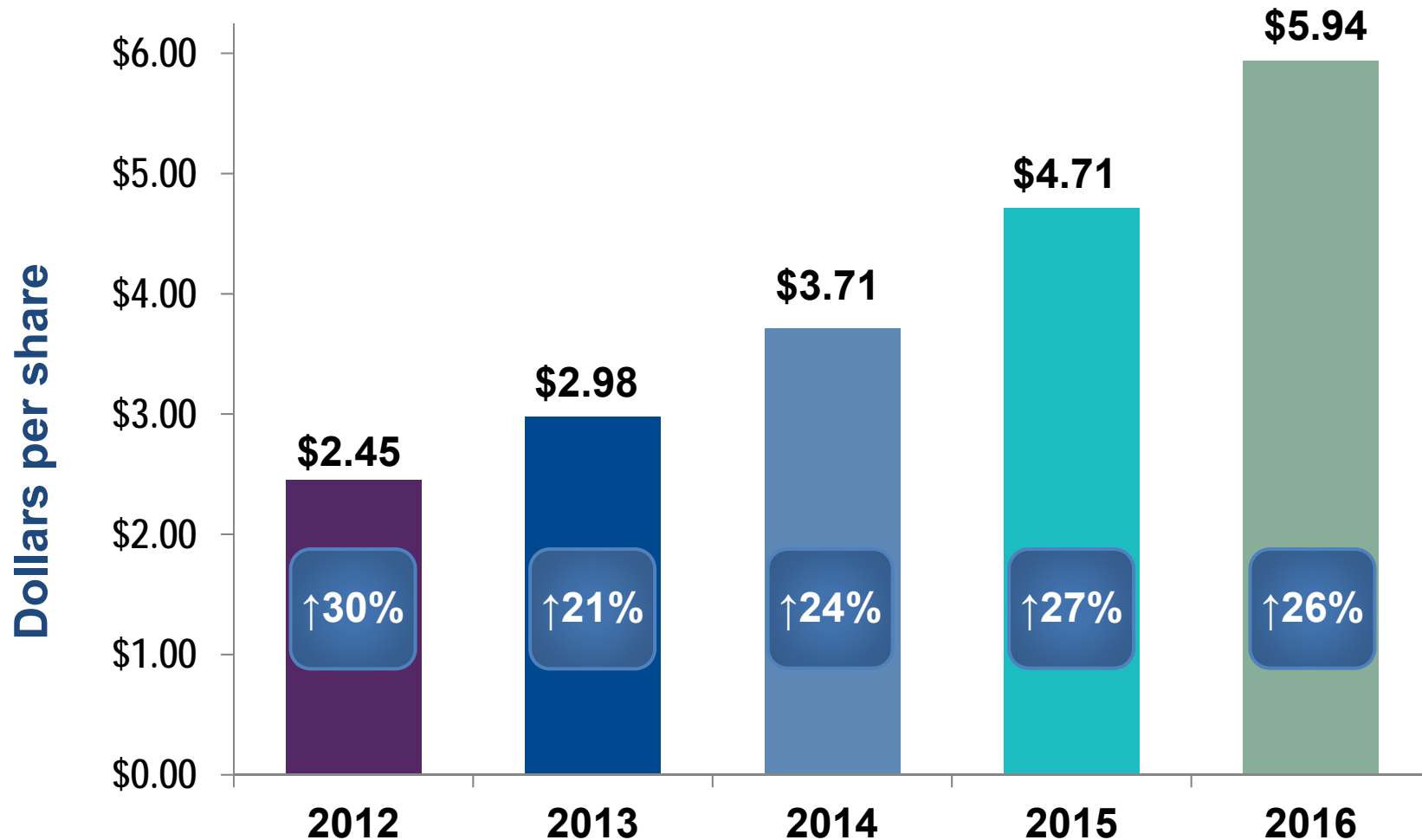


## Adjusted Diluted Earnings per Share (EPS)
