CIM Commercial Trust Announces Repurchase of 3.6 Million Shares

DALLAS--(BUSINESS WIRE)-- CIM Commercial Trust Corporation (NASDAQ:CMCT), a real estate investment trust (REIT) that principally invests in, owns, and operates Class A and creative office investments in vibrant and improving urban communities throughout the U.S., today announced that it has repurchased in a privately negotiated transaction 3,628,116 shares of its common stock from a fund (the "Fund") managed by an affiliate of CIM Group, the manager of CMCT. The aggregate purchase price was \$79,818,551, or \$22 per share.

These repurchases are part of CMCT's previously stated goal of providing liquidity to common shareholders at prices reflecting net asset value and cash flow prospects. In furtherance of this goal, CMCT intends to engage in additional repurchases within the next twelve months that would allow its other shareholders to participate in an equitable manner.
