### Explanation of Responses:

- (1) The reported shares are represented by restricted stock units, or RSUs, which will vest upon the satisfaction of both a performance condition and a service condition. The performance condition will be satisfied on the earlier of (i) March 8, 2014 (which the Issuer may elect to accelerate to February 15, 2014) and (ii) the date of a change in control. Upon the satisfaction of the performance condition, the total number of shares of common stock underlying the RSUs vest in eight equal quarterly installments beginning on July 1, 2014.
- (2) Of the reported shares, 726,290 shares are represented by RSUs.
