

SUBSCRIPTION AGREEMENT

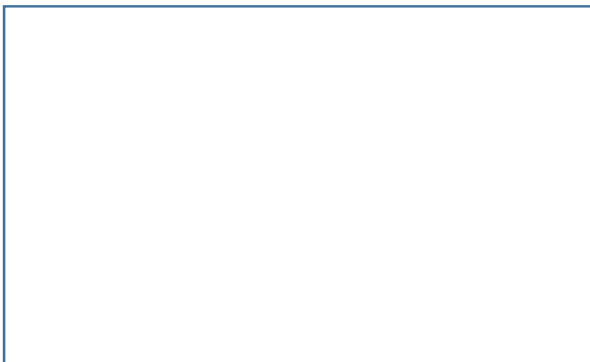
