PennTex Midstream Partners, LP Appoints Richard S. Walker to Its Board of Directors

Mr. Walker has announced that he will complete his service with the Venoco board effective August 1, 2015. Mr. Walker is also an advisory director of ASCENDE and board member of Strake Jesuit College Preparatory in Houston.

"Rick's experience across the financial, human capital and E&P sectors brings valuable insight as we continue to build out our organization and expand our midstream business."
