Naval Surface Warfare Center Dahlgren Awards ManTech \$39 Million for Navy's Fleet Support Mission

HERNDON, Va., July 07, 2017 (GLOBE NEWSWIRE) -- The Naval Surface Warfare Center Dahlgren Division (NSWCDD)/Combat Direction Systems Activity (CDSA), Dam Neck has awarded ManTech International Corporation (Nasdaq:MANT) a five year, \$39 million prime contract for the Navy's Fleet Support.
