## **ManTech Names Richard J. Wagner President of its Mission, Cyber & Intelligence Solutions Group**

"Rick" Wagner has been promoted to president of its Mission, Cyber & Intelligence Solutions (MCIS) Group. Earlier in his career, Wagner held management positions at Lockheed Martin and Raytheon, and worked as a software engineer and project manager for the Naval Surface Warfare Center.
