ManTech Wins \$133 Million Contract With U.S. Army INSCOM

HERNDON, Va., Jan. 30, 2018 (GLOBE NEWSWIRE) -- ManTech International Corporation (Nasdaq:MANT) today announced a \$133 million award from the U.S. Army Intelligence & Security Command to support INSCOM's central mission of counter-intelligence and counter-terrorism.
