## **STATE, LOCAL OFFICIALS JOIN PENNSYLVANIA AMERICAN WATER TO DEDICATE NEW WATER SERVICE FOR HANOVER TOWNSHIP RESIDENTS**

**MCMURRAY, Pa. (August 15, 2008)** – Representatives of Pennsylvania American Water gathered with state and local officials today to dedicate the extension of two miles of pipe, which the company is currently installing to provide public water service and improved fire protection to 30 customers in Hanover Township, Washington County.

Dignitaries participating in the ceremony included Pennsylvania Public Utility Commissioner Tyrone J. Christy, Pa State Rep. Jesse White, Washington County Commissioners Diana L. Ireys and J. Bracken Burns, Sr. along with Pennsylvania American Water President Kathy L. Pape.

“Viable water systems are essential to strong Pennsylvania communities and we, at the Commission, regulate the rates and service of about 193 water and wastewater companies to ensure safe and reliable service,” said Christy. “The PENNVEST projects in Allegheny and Washington counties will provide more reliable water service. This extension of clean water to residents is one example of a successful public-private partnership.”

Pennsylvania American Water secured approximately \$2.4 million in low-interest financing from the Pennsylvania Infrastructure Investment Authority (PENNVEST) to install the Hanover Township pipeline and another water main extension in Collier Township, Allegheny County. Both projects will enable the company to bring public water service to families who currently depend on unreliable private wells, springs and cisterns for water.

“The Office of Consumer Advocate has been assisting the people of Collier and Hanover Township since 2001 in their efforts to obtain safe and reliable water service,” said Pennsylvania Consumer Advocate Sonny Popowsky. “I am thrilled that these residents’ efforts have finally produced a positive result, and that the people of Collier/Hanover Township will now be able to receive this essential service at a reasonable cost.”

In addition to the new pipe, the Hanover Township project includes the installation of approximately 10 new fire hydrants. Crews recently began construction of the main extension, which is expected to be completed in October.

“These projects are a great example of how public-private partnerships can work. Pennsylvania American Water, the PUC, Office of Consumer Advocate, PENNVEST and local officials, have pulled together to ensure funding for this important project,” said Pape. “The PENNVEST loans not only help water companies like ours reduce interest expense, but they also make it possible to provide more families with reliable service, better water quality and improved fire protection.”
