### **Ashland to increase prices for unsaturated polyester resin, epoxy vinyl ester resins and gelcoat in EMEA**

BARCELONA, Spain, January 5, 2017 – Ashland today announced it will increase the prices of its complete portfolio of unsaturated polyester resin, epoxy vinyl ester resins and Gelcoats in Europe, the Middle East and Africa (EMEA) by 100 Euros per ton. This increase will take effect January 15, 2017, or as soon as possible thereafter as contracts allow.

The pricing action is in addition to the pricing communication circulated on December 1, 2016 and is primarily driven by the continued escalation in costs for key raw materials at Ashland's manufacturing units. Responding to changing market conditions allows Ashland to continue to provide innovative products and industry-leading support that add value for customers.
