### **Ashland to increase prices for unsaturated polyester resin, epoxy vinyl ester resins and gelcoat in EMEA**

BARCELONA, Spain, January 25, 2017 – Ashland today announced it will increase the prices of its complete portfolio of unsaturated polyester resin, epoxy vinyl ester resins and Gelcoats in Europe, the Middle East and Africa (EMEA) by 100 Euros per ton. This increase will take effect February 1, 2017, or as soon as possible thereafter as contracts allow.

The pricing action is in addition to the price increases announced December 1, 2016, and January 5<sup>th</sup>, 2017. It is primarily driven by the continued escalation in costs for key raw materials at Ashland's manufacturing units. Responding to changing market conditions allows Ashland to continue to provide innovative products and industry-leading support that add value for customers.
