4 **YOU ARE HEREBY NOTIFIED**, that pursuant to an Order of the United  
5 States District Court for the Central District of California, Western Division, a  
6 hearing will be held on December 14, 2009, at 10:00 a.m., before the Honorable  
7 Manuel L. Real, United States District Judge, United States Courthouse,  
8 Courtroom 8, 312 North Spring Street, Los Angeles, California, for the purpose of  
9 determining whether the proposed partial settlement of the above captioned  
10 derivative action (the “Federal Derivative Action”) should be approved as fair,  
11 reasonable and adequate and whether a judgment dismissing certain Individual  
12 Defendants from the Federal Derivative Action with prejudice should be entered.  
13 In connection with the Settlement, Broadcom has received and will receive  
14 payments from its officers and directors liability insurance carriers and other  
15 consideration totaling more than \$118,000,000, and certain current and former  
16 Broadcom officers and directors will be released from liability to Broadcom. In  
17 addition, Broadcom has agreed to pay \$11,500,000, and Lead Federal Derivative  
18 Plaintiffs’ Counsel will apply for an award in that amount, for attorneys’ fees,  
19 expenses and costs of plaintiffs’ counsel in connection with the Settlement and their  
20 prosecution of the Federal Derivative Action, subject to Court approval.

21 **IF YOU ARE A CURRENT OWNER OF BROADCOM COMMON**  
22 **STOCK YOUR RIGHTS MAY BE AFFECTED BY PROCEEDINGS IN THE**  
23 **DERIVATIVE ACTION.** A more detailed form of notice describing the

25 Securities and Exchange Commission and has been published on Broadcom’s  
26 company website.
