This Schedule 13G is being filed on behalf of (i) Mitchell P. Kopin, an individual who is a citizen of the United States of America (“ **Mr. Kopin** ”), (ii) Daniel B. Asher, an individual who is a citizen of the United States of America (“ **Mr. Asher** ”) and (iii) Intracoastal Capital LLC, a Delaware limited liability company (“ **Intracoastal** ” and together with Mr. Kopin and Mr. Asher, collectively the “ **Reporting Persons** ”).

The Reporting Persons have entered into a Joint Filing Agreement, a copy of which is filed with this Schedule 13G as **Exhibit 1**, pursuant to which the Reporting Persons have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k) of the Securities Exchange Act of 1934, as amended.

#### Item 4. Ownership.

(a) and (b):

(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on July 6, 2017 (the “SPA”) (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on July 6, 2017), each of the Reporting Persons may be deemed to have beneficial ownership of 656,443 shares of Common Stock, which consists of (i) 645,000 shares of Common Stock that was to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (ii) 11,443 shares of Common Stock issuable upon exercise of a warrant that was to be issued to Intracoastal at the closing of the transaction contemplated by the SPA (“**Intracoastal Warrant 1**”), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 9.99% of the Common Stock, based on (1) 5,914,560 shares of Common Stock outstanding as of July 6, 2017 as reported by the Issuer, plus (2) 645,000 shares of Common Stock that were to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (3) 11,443 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1. The foregoing excludes (I) 633,557 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1 because Intracoastal Warrant 1 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 1 to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 9.99% of the Common Stock, (II) 645,000 shares of Common Stock issuable upon exercise of a second warrant that was to be issued to Intracoastal at the closing of the transaction contemplated by the SPA (“**Intracoastal Warrant 2**”) because Intracoastal Warrant 2 is not exercisable until December 22, 2017 (and Intracoastal Warrant 2 also contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 2 to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 9.99% of the Common Stock), (III) 2,425 shares of Common Stock issuable upon exercise of a third warrant held by Intracoastal (“**Intracoastal Warrant 3**”) because Intracoastal Warrant 3 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 3 to the extent that such exercise would result in beneficial ownership by the holder thereof, together with any persons whose beneficial ownership of the Common Stock would or could be aggregated with such holder’s for purposes of Section 13(d) of the Securities Exchange Act of 1934, of more than 4.99% of the Common Stock. Without such blocker provisions (and assuming Intracoastal Warrant 2 was currently exercisable), each of the Reporting Persons may have been deemed to have beneficial ownership of 1,937,425 shares of Common Stock.

(ii) As of close of business on July 14, 2017, each of the Reporting Persons may have been deemed to have beneficial ownership of 712,500 shares of Common Stock, which consisted of (i) 67,500 shares of Common Stock held by Intracoastal and (ii) 645,000 shares of Common Stock issuable upon exercise of the Intracoastal Warrant 1, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 8.3% of the Common Stock, based on (1) 5,914,560 shares of Common Stock outstanding as of July 6, 2017 as reported by the Issuer, plus (2) 2,050,000 shares of Common Stock in the aggregate issued at the closing of the transaction contemplated by the SPA and (3) 645,000 shares of Common Stock issuable upon exercise of the Intracoastal Warrant 1. The foregoing excludes (I) 645,000 shares of Common Stock issuable upon exercise of the Intracoastal Warrant 2 because Intracoastal Warrant 2 is not exercisable until December 22, 2017 (and Intracoastal Warrant 2 also contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 2 to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 9.99% of the Common Stock) and (II) 2,425 shares of Common Stock issuable upon exercise of the Intracoastal Warrant 3 because Intracoastal Warrant 3 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 3 to the extent that such exercise would result in beneficial ownership by the holder thereof, together with any persons whose beneficial ownership of the Common Stock would or could be aggregated with such holder’s for purposes of Section 13(d) of the Securities Exchange Act of 1934, of more than 4.99% of the Common Stock. Without such blocker provisions (and assuming Intracoastal Warrant 2 was currently exercisable), each of the Reporting Persons may have been deemed to have beneficial ownership of 1,359,925 shares of Common Stock.
