Comtech Telecommunications Corp. Receives \$3.3 Million of Additional Orders on Its Movement Tracking System Contract

Comtech Telecommunications Corp. (NASDAQ:CMTL) announced today that its Maryland-based subsidiary, Comtech Mobile Datacom Corp., has recently received \$3.3 million of orders relating to its Movement Tracking System, or MTS, contract with the U.S. Army Logistics Command. These orders, which include a \$1.1 million order for installation, training and support, bring the total orders on the contract to-date to approximately \$74.8 million.

The orders received since the Company's fiscal year-end are for both equipment and services. The equipment orders are for mobile satellite transceivers and related hardware, as well as installation kits. The remaining orders are for installation, training and support activities in Kuwait, Iraq and selected Army bases in the United States.

Fred Kornberg, President and Chief Executive Officer of Comtech Telecommunications Corp., said, "We continue to receive orders on the MTS program from the U.S. Army's fiscal 2003 budget. These orders are evidence of the Army's continuing interest in this program."
