## Compass Diversified Holdings Declares First Quarter 2017 Distribution of \$0.36 Per Share

**Westport, Conn., April 6, 2017** - Compass Diversified Holdings (NYSE: CODI) (“CODI” or the “Company”), an owner of leading middle market businesses, announced today that its Board of Directors has declared a quarterly cash distribution of \$0.36 per share. The distribution for the three months ended March 31, 2017 is payable on April 27, 2017 to all holders of record as of April 20, 2017.

Alan Offenberg, CEO of Compass Diversified Holdings, stated, “We are pleased to declare our first quarter distribution of \$0.36 per share. We have now declared a distribution each quarter since our IPO in May of 2006 and, including this quarter, will have cumulatively distributed \$14.9952 per share to our shareholders.”
