Conn's, Inc. Announces Pricing of New \$700 Million Securitization Transaction

THE WOODLANDS, Texas--(BUSINESS WIRE)-- **Conn's, Inc. (NASDAQ:CONN)**, today announced that it has entered into an agreement to securitize an aggregate of approximately \$700 million of retail installment contract receivables, with closing expected on or about October 6, 2016.

The offering includes three classes of fixed rate notes: (i) \$391,840,000 aggregate principal amount of the Class A asset backed notes are expected to be rated BBBsf by Fitch, (ii) \$111,960,000 aggregate principal amount of the Class B asset backed notes are expected to be rated BBSf by Fitch, and (iii) \$48,980,000 aggregate principal amount of the Class C asset backed fixed rate notes are expected to be rated Bsf by Fitch.

The face amount of the Class A and Class B notes to be issued in the securitization is \$503.8 million, with an advance rate of approximately 72% of the outstanding customer receivables portfolio balance. Conn's will receive upfront proceeds with respect to those notes of approximately \$488 million, net of transaction costs and reserves. The coupon rate to investors is 3.73% on the Class A Notes and 7.34% on the Class B Notes. The Class C Notes and residual equity will initially be retained by an affiliate of the Company.

The notes will not be registered under the Securities Act of 1933, as amended (the "Securities Act"), and may not be offered or sold in the United States absent registration or an applicable exemption from registration requirements. The notes will be offered only (i) within the United States to persons who are qualified institutional buyers as defined in Rule 144A under the Securities Act, and (ii) solely with respect to the Class A Notes, to certain non-U.S. persons in offshore transactions in reliance on Regulation S under the Securities Act. Conn's is a specialty retailer currently operating over 110 retail locations in Alabama, Arizona, Colorado, Georgia, Louisiana, Mississippi, Nevada, New Mexico, North Carolina, Oklahoma, South Carolina, Tennessee and Texas. The Company's primary product categories include:

- l Furniture and mattress, including furniture and related accessories for the living room, dining room and bedroom, as well as both traditional and specialty mattresses;
- l Home appliance, including refrigerators, freezers, washers, dryers, dishwashers and ranges;
- l Consumer electronics, including LED, OLED, Ultra HD and internet-ready televisions, Blu-ray players, home theater and portable audio equipment; and
- l Home office, including computers, printers and accessories.

Additionally, Conn's offers a variety of products on a seasonal basis. Unlike many of its competitors, Conn's provides flexible in-house credit options for its customers in addition to third-party financing programs and third-party rent-to-own payment plans.
