## **Departure of Directors or Certain Officers; Appointment of Certain Officers.**

DynCorp International today announced the appointment of William T. Kansky, age 49, as Senior Vice President and Chief Financial Officer (CFO) effective August 9, 2010. Mr. Kansky will replace Mike Thorne, who announced his resignation effective August 9, 2010, to pursue other opportunities. Mr. Thorne leaves DynCorp International after almost 10 years with the Company and more than five as CFO, a role in which he provided strong financial leadership through several key chapters in the Company's history including, most recently, the successful completion of the merger with affiliated funds of Cerberus Capital Management L.P.

Mr. Kansky will join DynCorp International from ITT Corporation, where he was Vice President and CFO of ITT Corporation's Defense and Information Systems business unit. Prior to joining ITT Corporation in 1996, Mr. Kansky worked in the finance organizations of Westinghouse Broadcasting Company and Group W Information Services. Together with other previous employment, Mr. Kansky has spent the last 20 years in various senior finance leadership positions and possesses extensive experience in the defense and government contracting industry. He holds a Bachelor of Science Degree in Finance from Central Connecticut State University.
