Explanation of Responses:

- (1) The restricted stock units were awarded under the Energy XXI Gulf Coast, Inc. 2016 Long Term Incentive Plan to Mr. Bahorich.
- (2) Each restricted stock unit represents a contingent right to receive one share of common stock, par value \$0.01 per share, of Energy XXI Gulf Coast, Inc.
- (3) The original filing inadvertently placed the number of restricted stock units awarded to the Reporting Person under column 5(D) (disposition) of Table II instead of column 5(A) (acquisition). The Transaction Code (A) used in the original filing made clear that the award of restricted stock units was an acquisition exempt under Rule 16b3-1.
- (4) The restricted stock units will vest 100% on the date of the 2018 annual meeting of stockholders of Energy XXI Gulf Coast, Inc., so long as Mr. Bahorich is a member of the Board immediately prior to such stockholder meeting.
