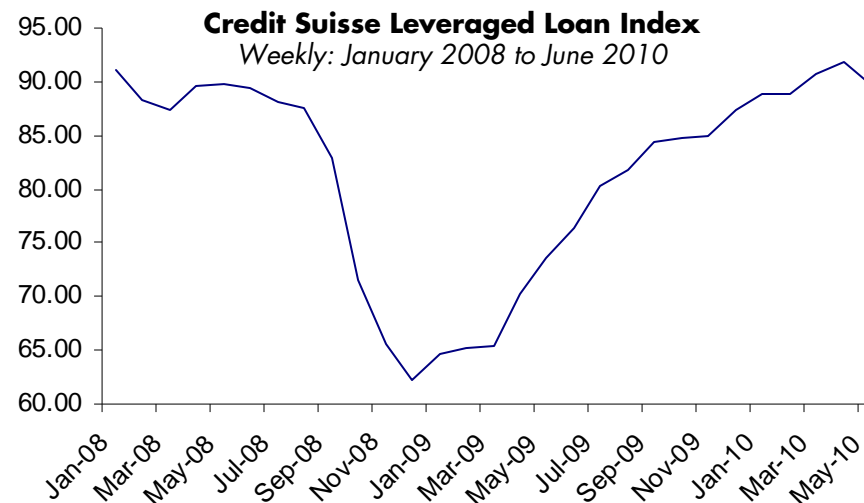
Attractive Risk- Adjusted Portfolio

Market Update

- Following a strong 2009 performance, the loan market started 2010 with a strong positive tone, but confidence has since been shaken by the sovereign debt crisis in Europe. Since the start of the year, the average price on the CS Leveraged Loan index increased by 2.3 points to 89.7
- The continued positive performance is due to improving economic conditions, lower default rates and strong technicals:
 - Issuer earnings are stabilizing and in many cases improving. Ability to access markets has reduced liquidity and refinancing concerns
 - More than \$60bn of institutional loans have been refinanced, mainly as a result of a record pace of HY issuance, providing liquidity to the market participants
 - Strong retail cash inflows in the leveraged loan markets support prices, driven by the search for yield in a low-rate environment

- High yield bond spreads have widened from 634bps at the end of 2009 to 687bps as of June 24, 2010 ⁽¹⁾, after tightening to 572bps at the end of April
 - \$4bn of mutual fund outflows since the end of April and weak equity markets have weighed on high yield performance

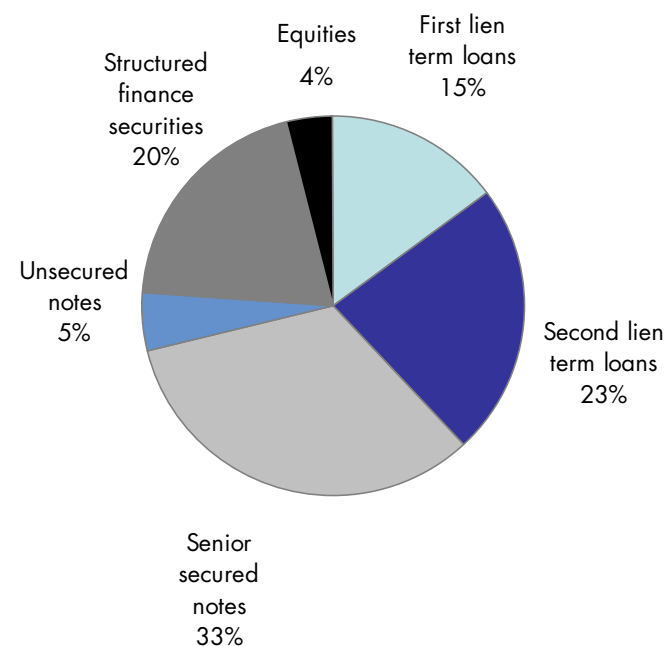

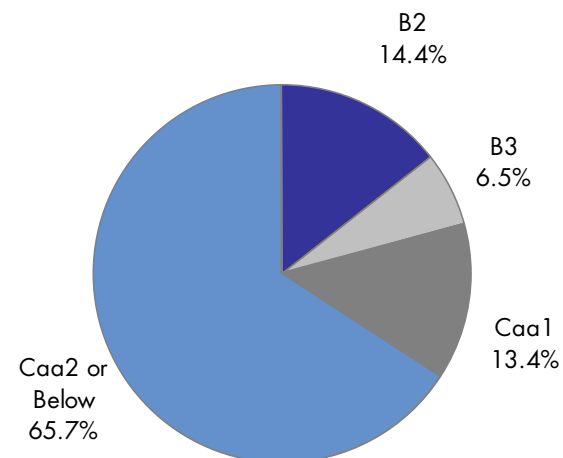

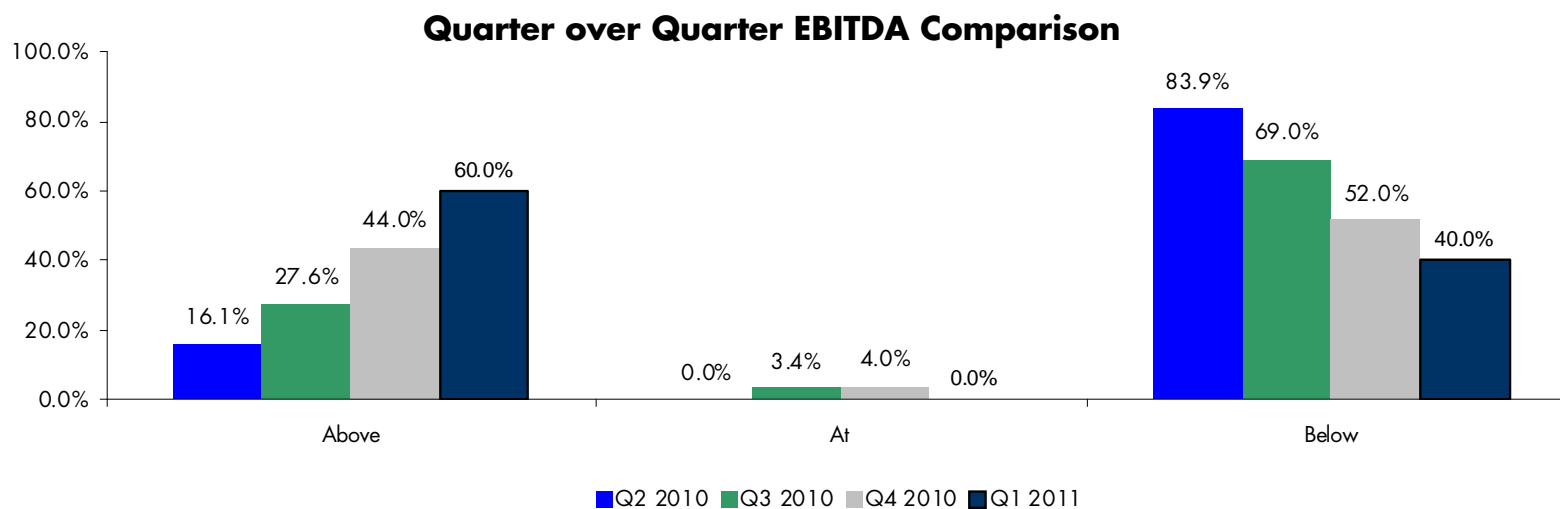
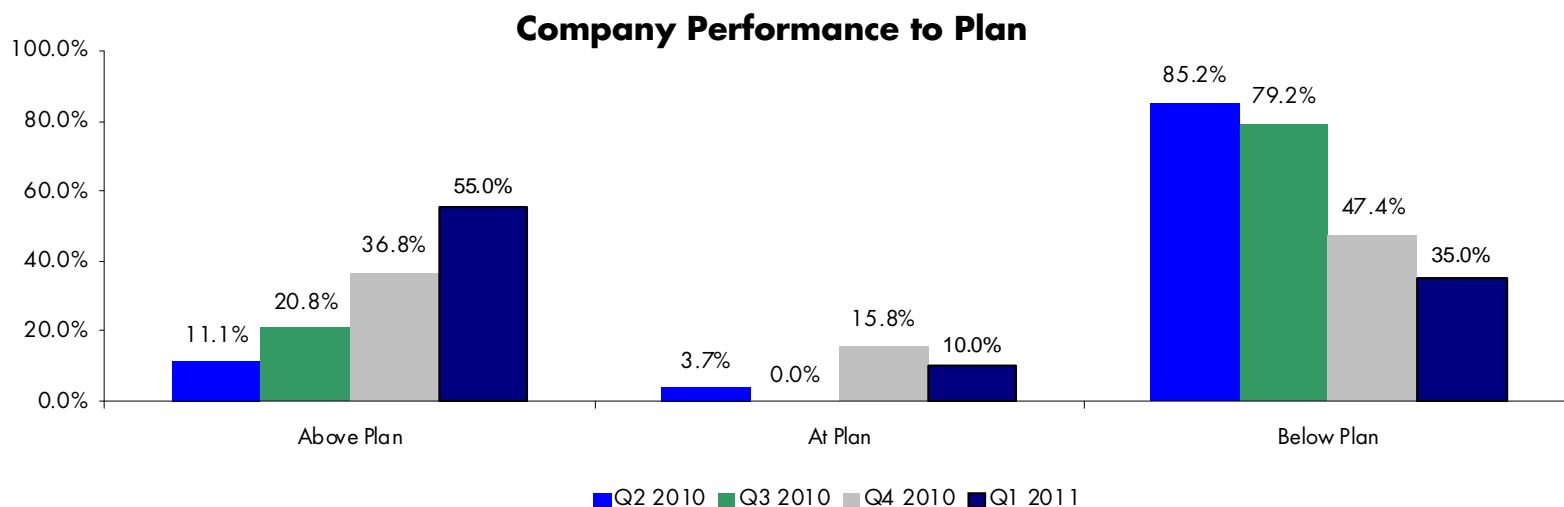

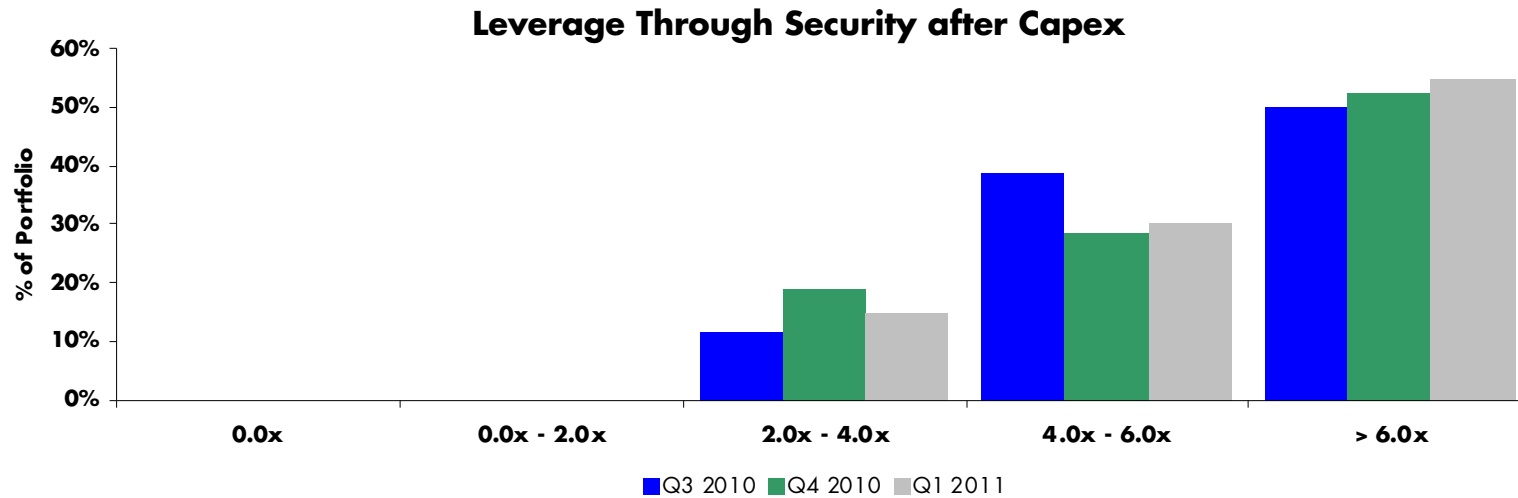
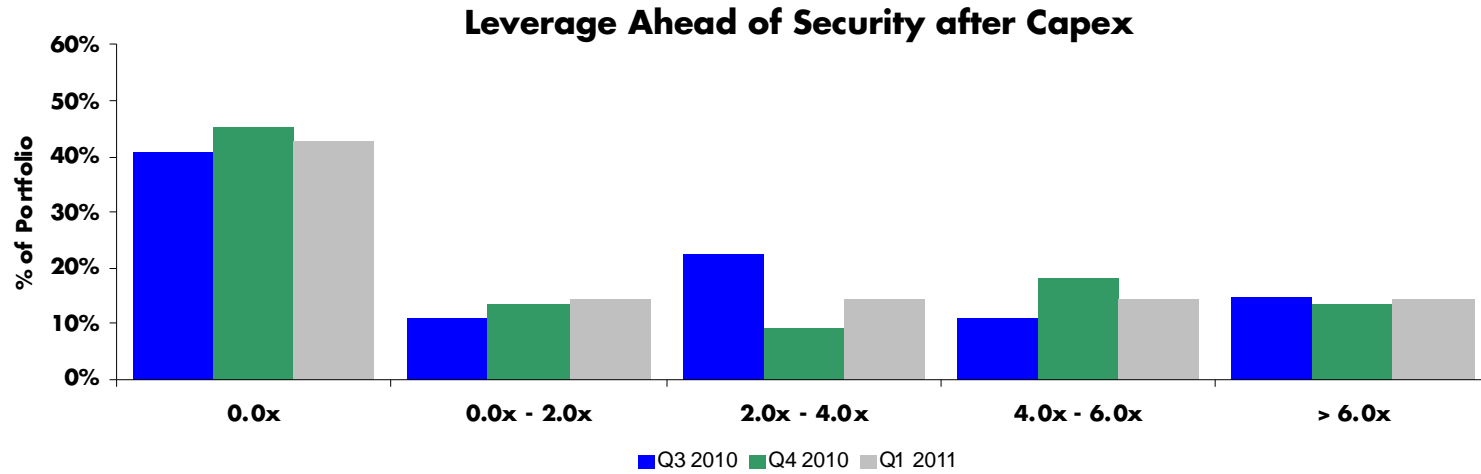

First Quarter Leverage Statistics for Balance Sheet Investments



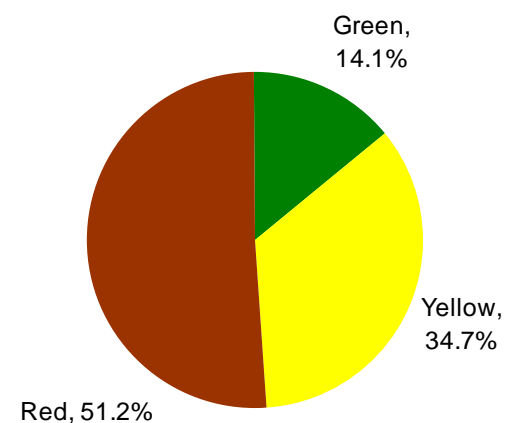

of Credits by Classification**



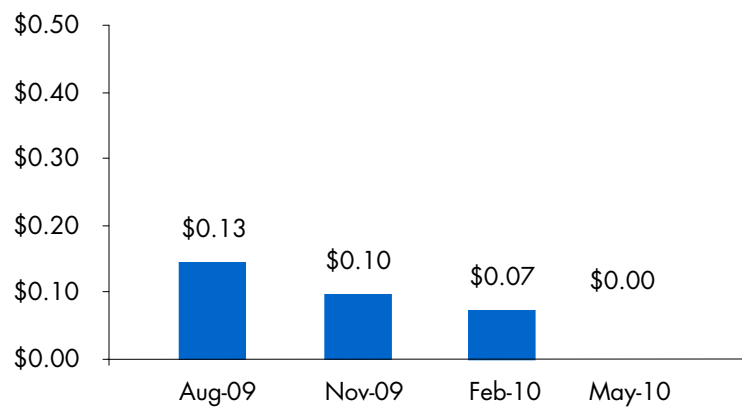

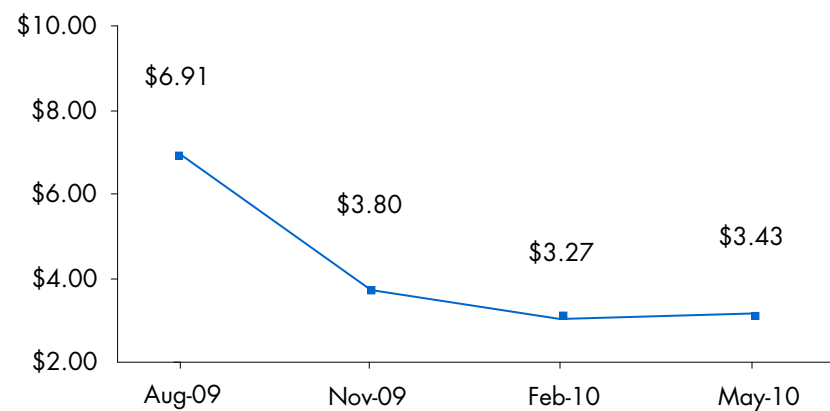
