During the second quarter of 2009, The Hartford, including the First State Insurance Companies (the "Company"), completed its annual ground up asbestos reserve evaluation. As part of this evaluation, the Company reviewed all of its open direct domestic insurance accounts exposed to asbestos liability as well as assumed reinsurance accounts. Based on this evaluation, the Company increased its gross asbestos reserves by \$100,000,000 and its net asbestos reserves by \$80,000,000, before ceding all of the \$80,000,000 to Hartford Fire Insurance Company ("Hartford Fire"), under the Company's stop loss reinsurance agreement with Hartford Fire. As a result of the Stop Loss cession, there was no increase to net asbestos reserves and therefore no net incurred impact. Based on the Company's statutory intercompany pooling arrangement, New England Reinsurance Corporation's 1% share of the \$100 million Gross and Ceded (after stop loss) asbestos reserve increase is \$1,000,000.
