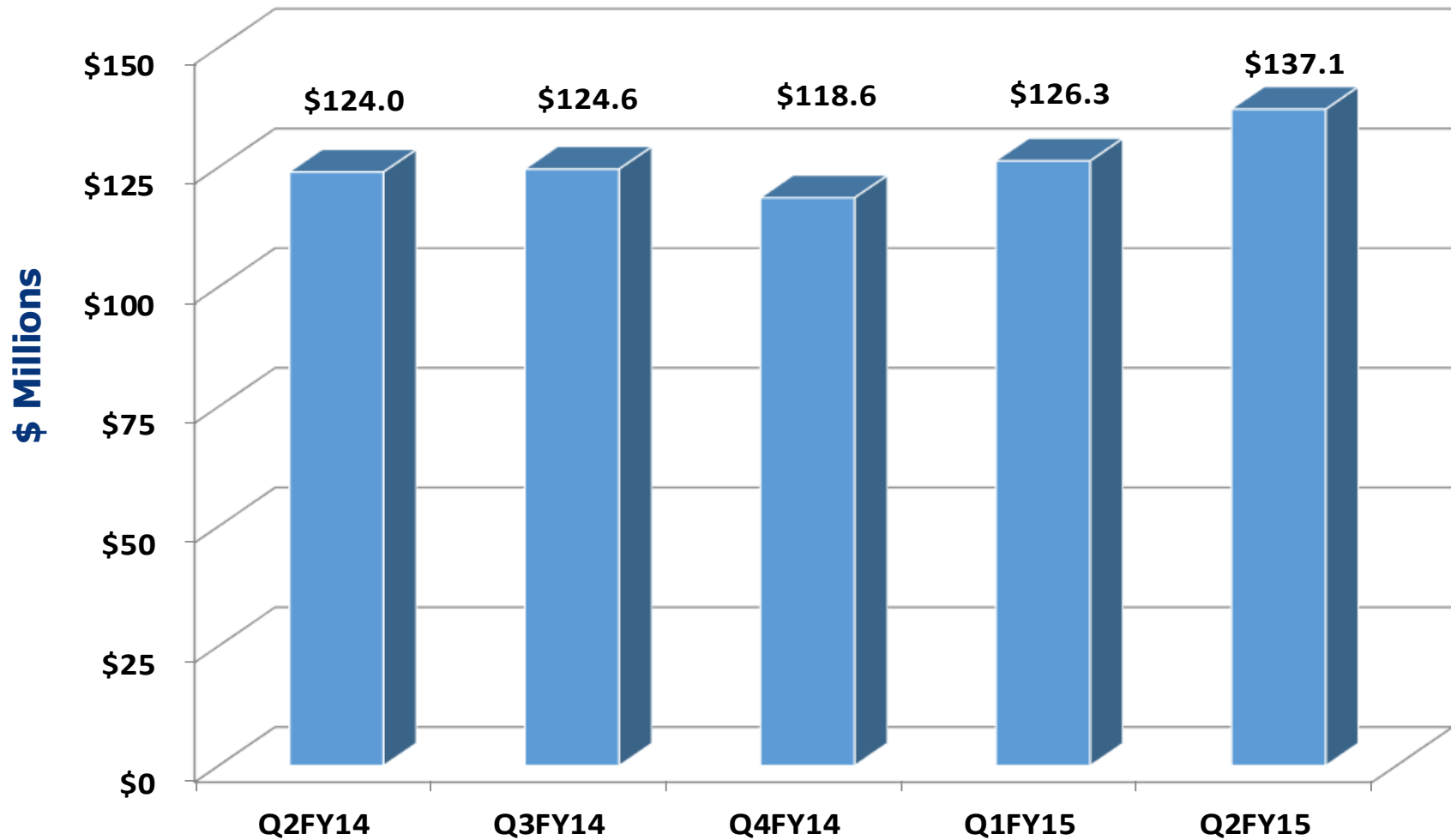

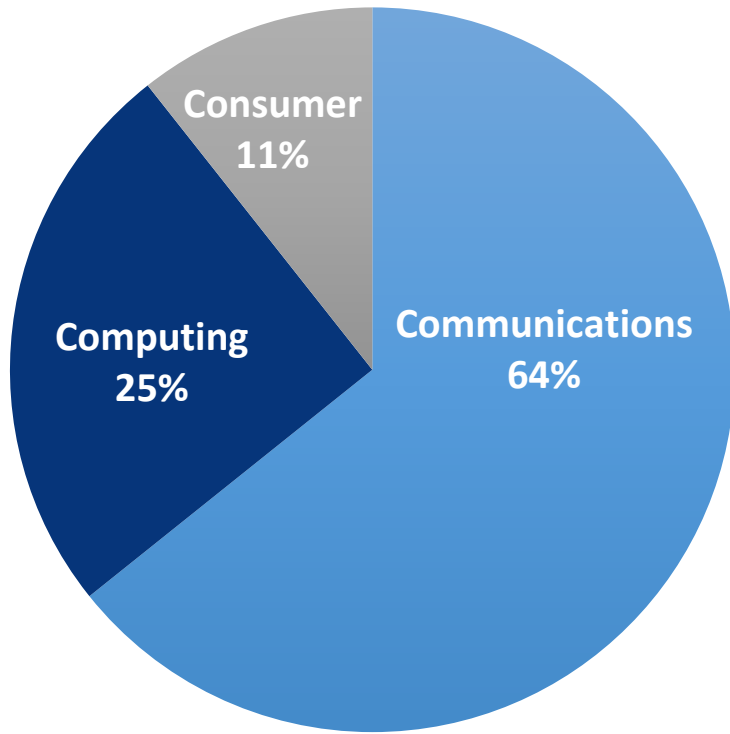

Revenue*

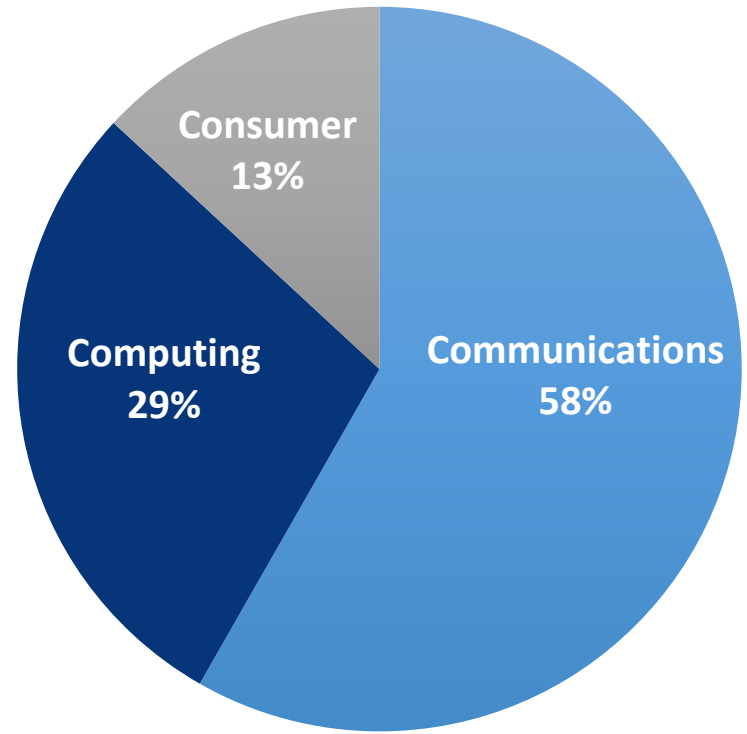

Revenue* by End Market



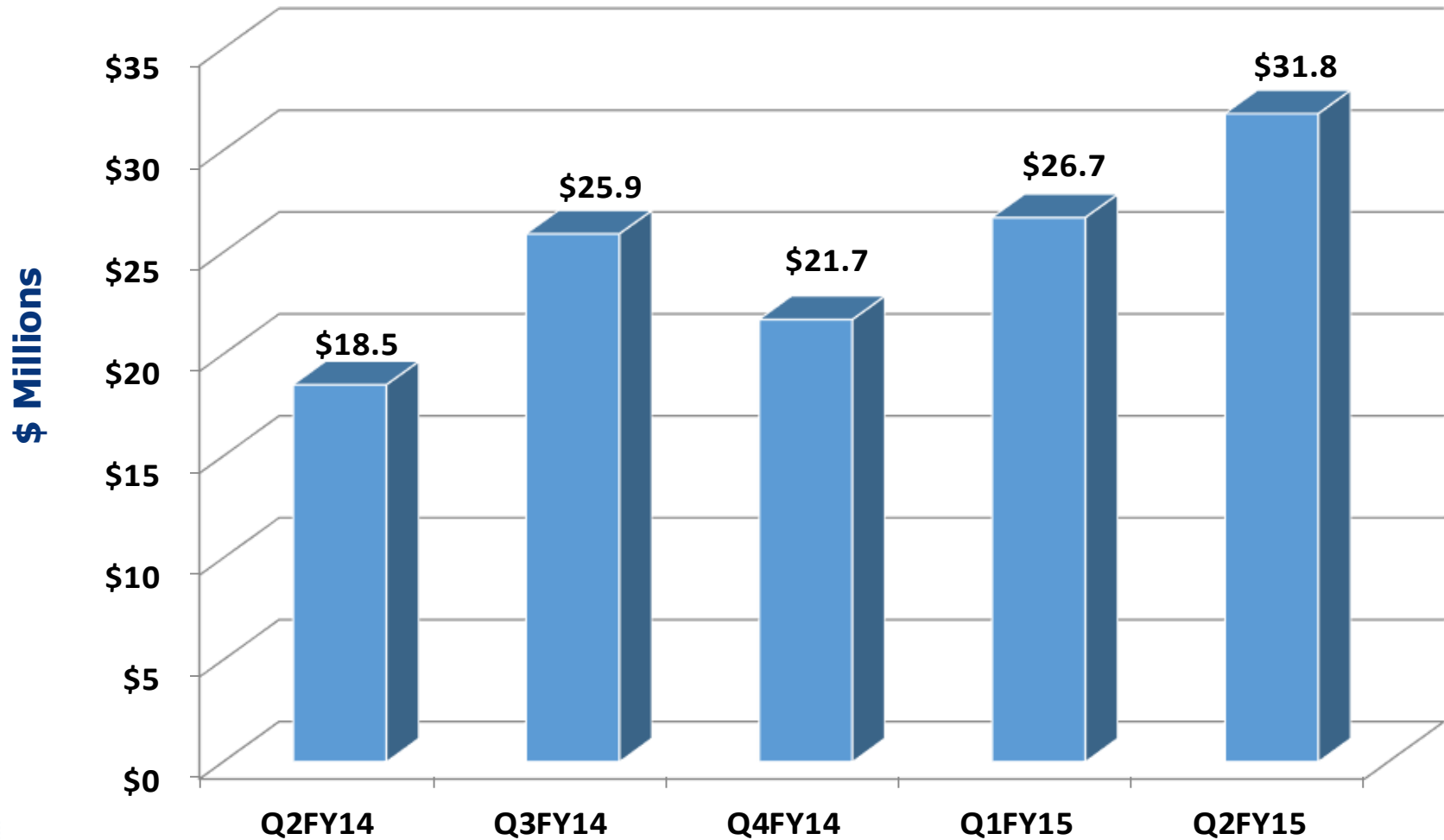
Fiscal Q1 2015
