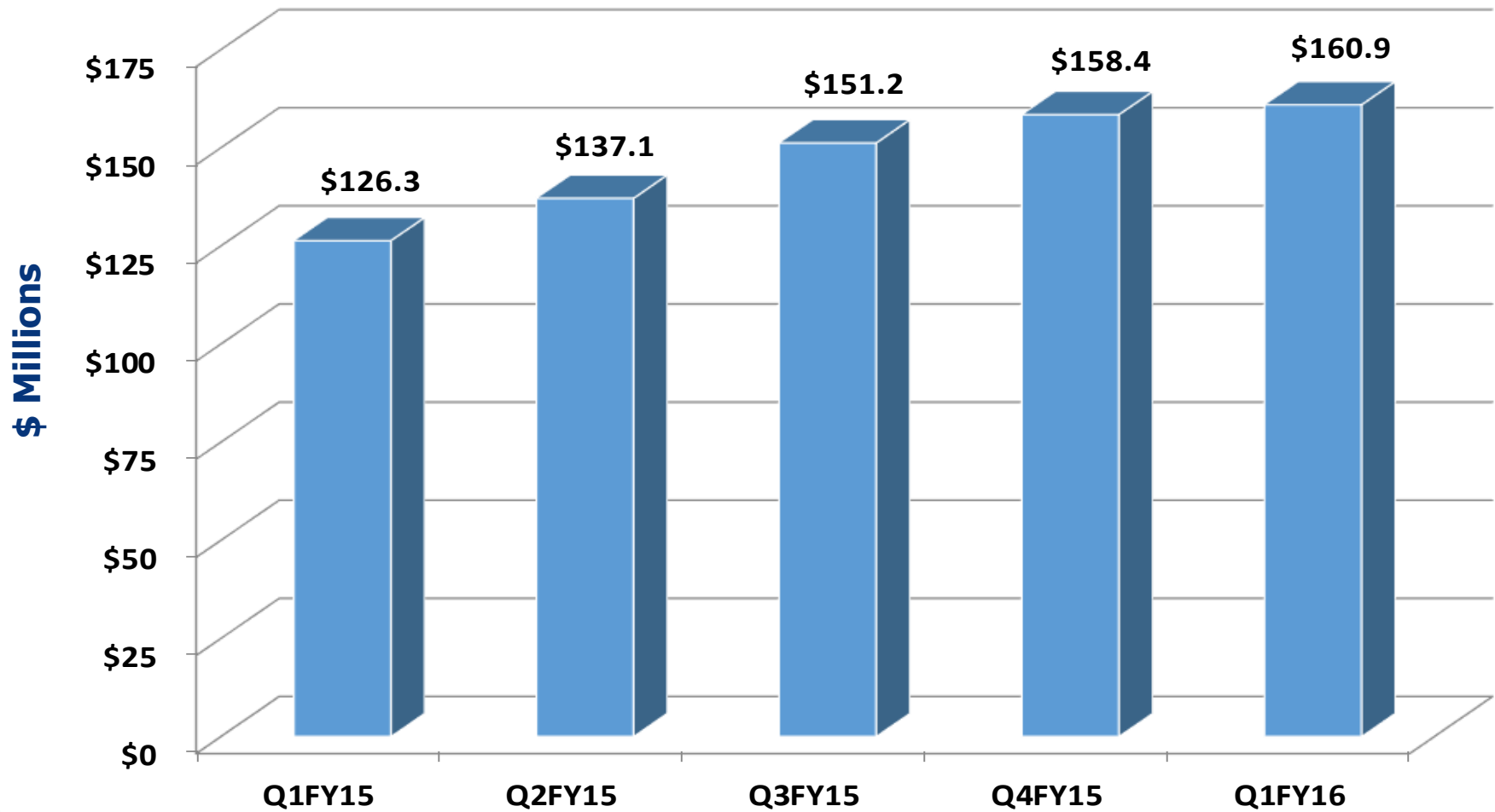

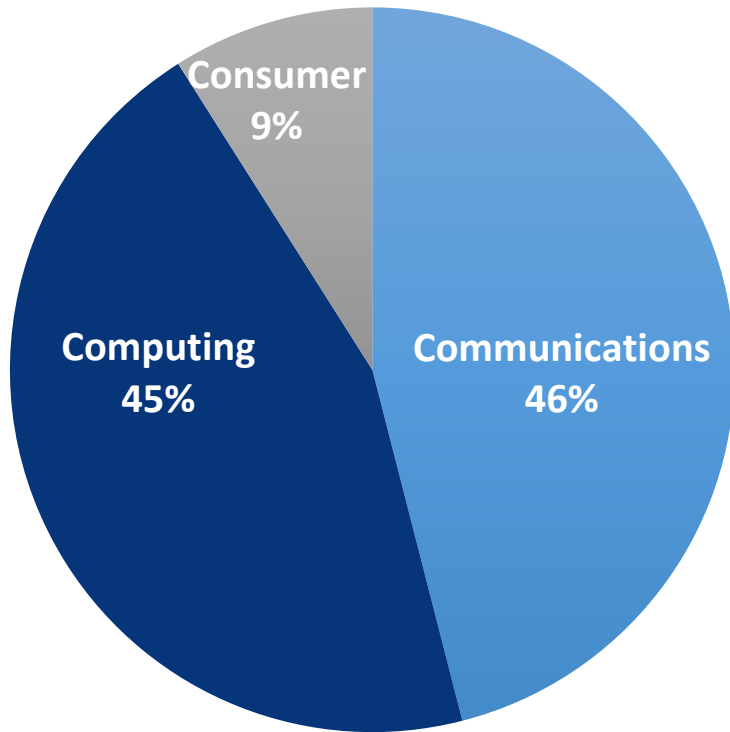

Revenue*

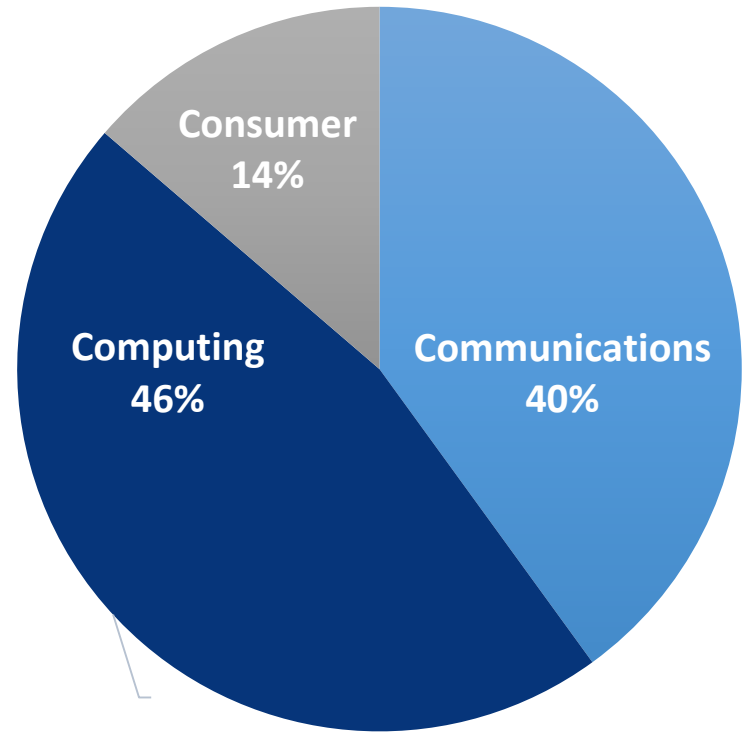

Revenue* by End Market



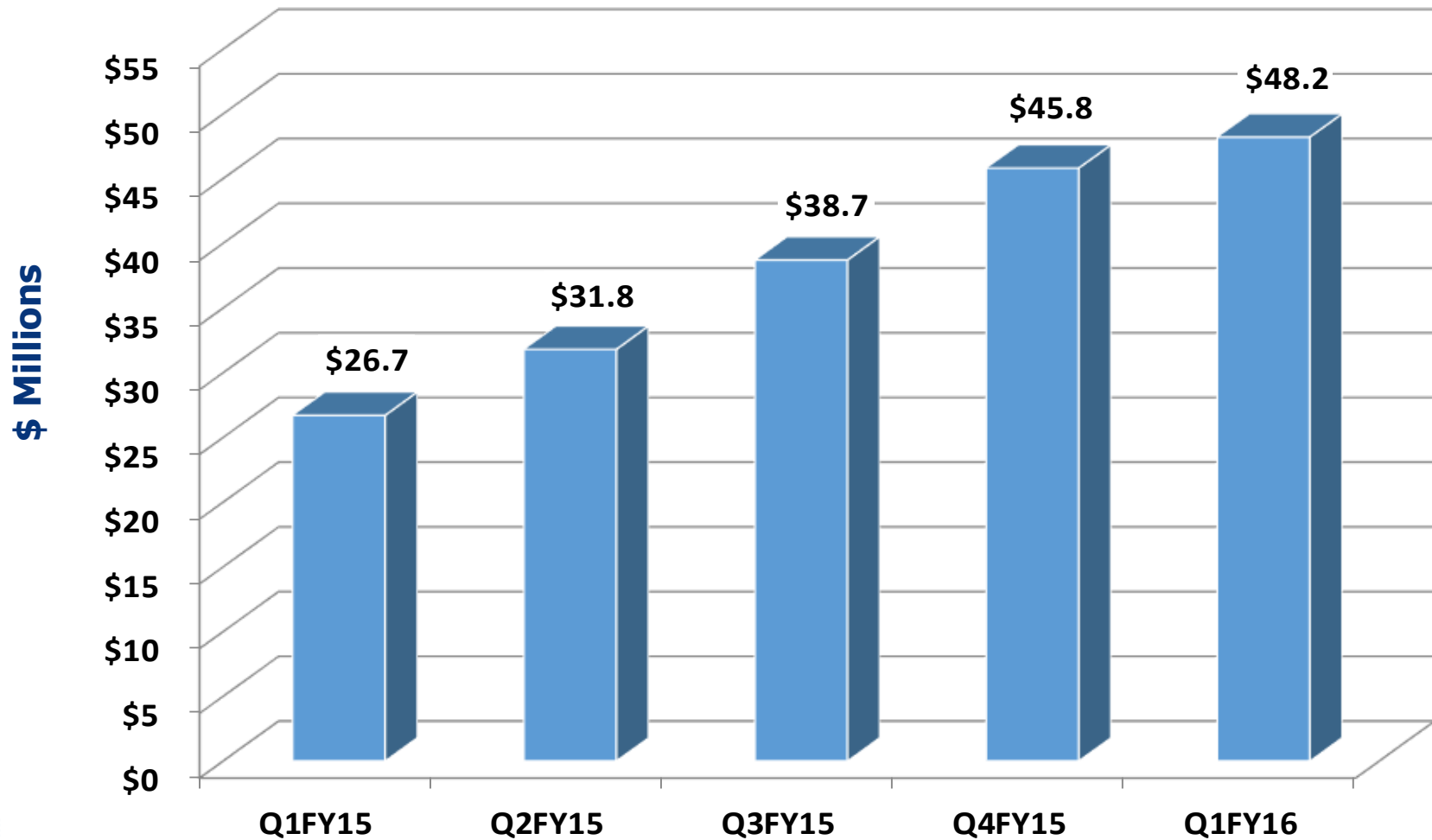
Fiscal Q4 2015
