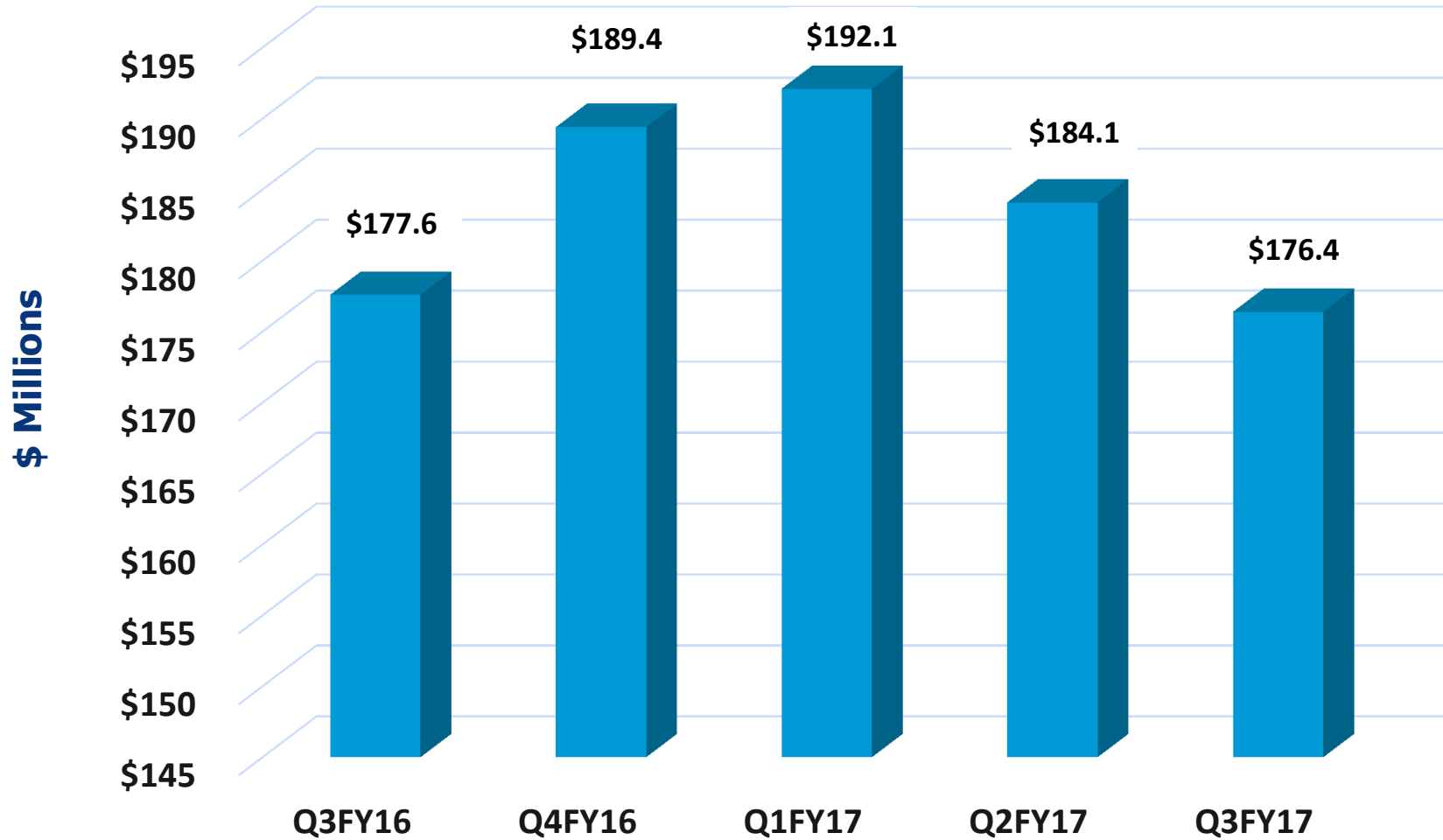

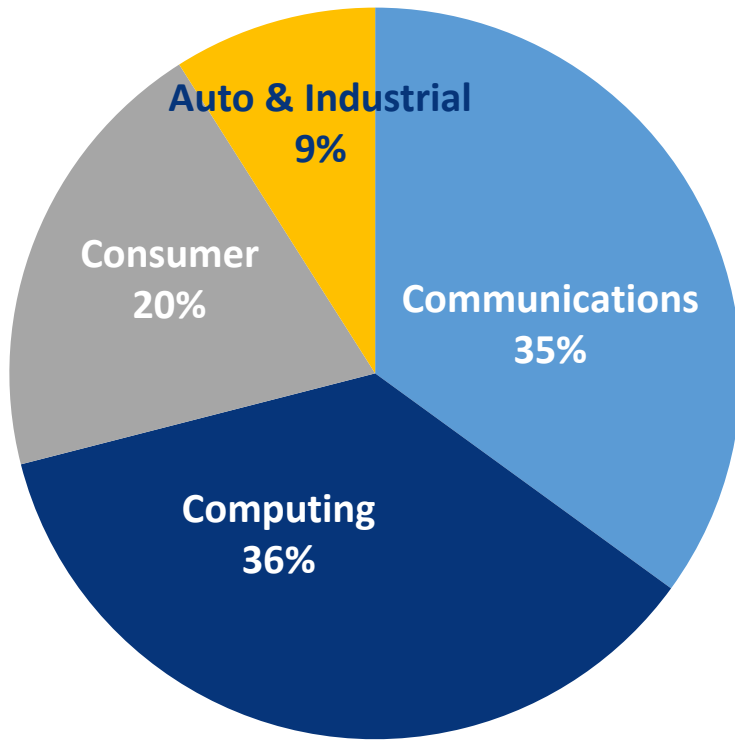

Revenue*

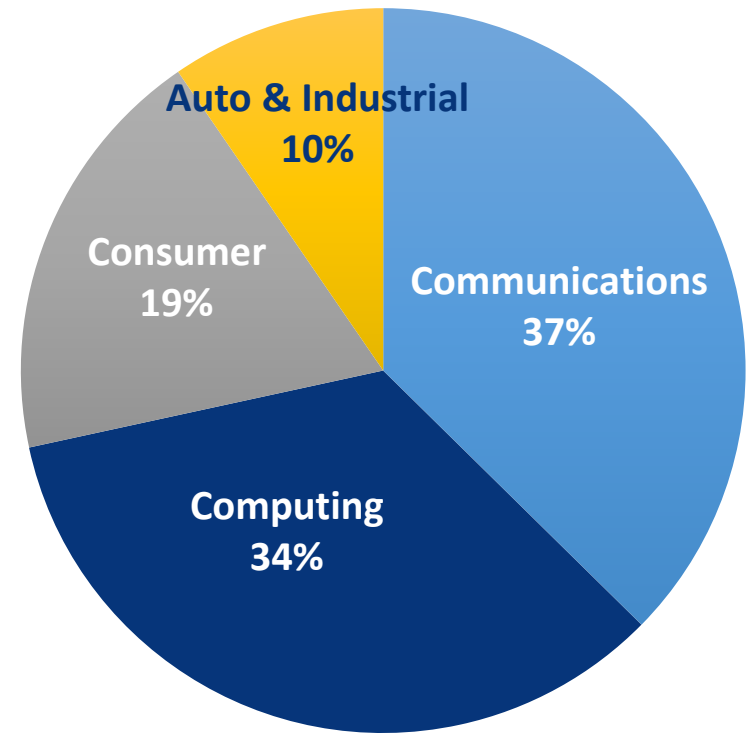

Revenue* by End Market



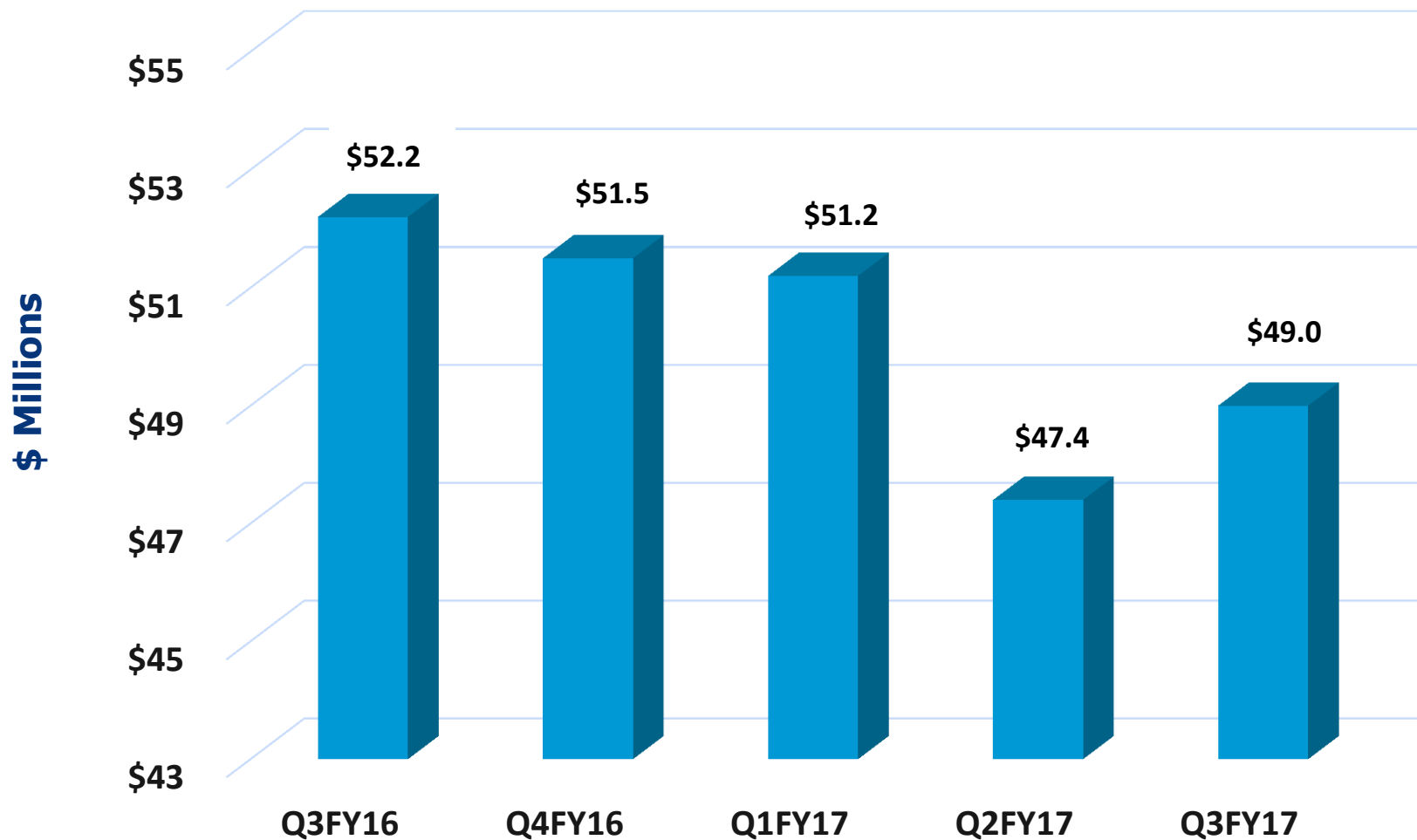
Fiscal Q2 2017
