### Least Performing Index Annual Review Notes Linked to the S&P 500<sup>®</sup> Index, the Dow Jones EURO STOXX 50<sup>®</sup> Index and the Nikkei 225 Index due September 15, 2010

#### General

- The notes are designed for investors who seek early exit prior to maturity at a premium if, on any one of the three annual Review Dates, each of the S&P 500<sup>®</sup> Index, the Dow Jones EURO STOXX 50<sup>®</sup> Index and the Nikkei 225 Index are at or above their respective Call Levels applicable to that Review Date. If the notes are not called, investors are protected at maturity against up to a 15% decline of any Index on the final Review Date but will lose some or all of their principal if any Index declines by more than 15%. Investors in the notes should be willing to accept this risk of loss, and be willing to forgo interest and dividend payments, in exchange for the opportunity to receive a call premium payment if the notes are called.
- The first Review Date, and therefore the earliest call date, is September 10, 2008.
- Senior unsecured obligations of JPMorgan Chase & Co. maturing September 15, 2010<sup>†</sup>.
- Minimum denominations of \$50,000 and integral multiples of \$1,000 in excess thereof.
- The notes are expected to price on or about September 4, 2007 and are expected to settle on or about September 7, 2007.

#### Key Terms

Indices:	The S&P 500 <sup>®</sup> Index, the Dow Jones EURO STOXX 50 <sup>®</sup> Index and the Nikkei 225 Index (each an “Index,” and collectively, the “Indices”).

We urge you to consult your investment, legal, tax, accounting and other advisers before you invest in the notes.

### Hypothetical Examples of Amounts Payable upon an Automatic Call or at Maturity

The following table illustrates the hypothetical simple total return (*i.e.*, not compounded) on the notes that could be realized on the applicable Review Date for a range of movements in the Indices as shown under the column “Level of Index with Least Performing Index Return Appreciation/Depreciation at Review Date.” **The following table assumes that the Least Performing Index for the entire term of the notes will be the Dow Jones EURO STOXX 50<sup>®</sup> Index. We make no representation or warranty as to which of the Indices will be the Least Performing Index for purposes of calculating your return on the notes on any Review Date or at maturity.** The following table assumes a Call Level of 3570 for the Least Performing Index on both the first and second Review Dates and a Call Level equal to a hypothetical Initial Index Level of 4200 for the Least Performing Index on the final Review Date. The table assumes that the percentages used to calculate the call price applicable to the first, second and final Review Dates are 17.55%, 35.10% and 52.65%, respectively, regardless of the appreciation of the Least Performing Index, which may be significant; the actual percentages will be determined on the pricing date. There will be only one payment on the notes, whether called or at maturity. An entry of “N/A” indicates that the notes would not be called on the applicable Review Date and no payment would be made for such date. The hypothetical returns set forth below are for illustrative purposes only and may not be the actual total returns applicable to a purchaser of the notes. For an automatic call to be triggered, the Index closing level for each Index must be greater than or equal to its respective Call Level on one of the Review Dates.

The following examples illustrate how the total returns set forth in the table on the previous page are calculated.

**Example 1: The level of the Least Performing Index decreases from the Initial Index Level of 4200 to an Index closing level of 3990 on the first Review Date.** Because the Index closing level of the Least Performing Index (3990) on the first Review Date is greater than the corresponding Call Level of 3570, the notes are automatically called, and the investor receives a single payment of \$1,175.50 per \$1,000 principal amount note.

**Example 2: The level of the Least Performing Index decreases from the Initial Index Level of 4200 to an Index closing level of 3360 on the first Review Date, 2940 on the second Review Date, and 3990 on the final Review Date.** Because (a) the Index closing level of the Least Performing Index on the first Review Date (3360) is less than the corresponding Call Level of 3570, (b) the Index closing level of the Least Performing Index on the second Review Date (2940) is less than the corresponding Call Level of 3570, (c) the Index closing level of the Least Performing Index on the final Review Date (3990) is less than the corresponding Call Level of 4200, and (d) the Ending Index Level of the Least Performing Index has not declined by more than 15% from the Initial Index Level, the notes are not called and the payment at maturity is the principal amount of \$1,000 per \$1,000 principal amount note.

**Example 3: The level of the Least Performing Index decreases from the Initial Index Level of 4200 to an Index closing level of 2940 on the first Review Date, 2520 on the second Review Date, and 3360 on the final Review Date.** Because (a) the Index closing level of the Least Performing Index on the first Review Date (2940) is less than the corresponding Call Level of 3570, (b) the Index closing level of the Least Performing Index on the second Review Date (2520) is less than the corresponding Call Level of 3570, (c) the Index closing level of the Least Performing Index on the final Review Date (3360) is less than the corresponding Call Level of 4200, and (d) the Ending Index Level of the Least Performing Index is more than 15% below the Initial Index Level, the notes are not called and the investor receives a payment at maturity that is less than the principal amount of each \$1,000 principal amount note calculated as follows:

$$\$1,000 + [\$1,000 \times (-20\% + 15\%) \times 1.1765] = \$941.18$$

### Selected Purchase Considerations

- **APPRECIATION POTENTIAL** — If the Index closing level for each Index is greater than or equal to its respective Call Level on a Review Date, your investment will yield a payment per \$1,000 principal amount note of \$1,000 plus: (i) at least 17.55%\* x \$1,000 if called on the first Review Date; (ii) at least 35.10%\* x \$1,000 if called on the second Review Date; or (iii) at least 52.65%\* x \$1,000 if called on the final Review Date. Because the notes are our senior unsecured obligations, payment of any amount if called or at maturity is subject to our ability to pay our obligations as they become due.  
\* The actual percentage applicable to the Review Dates above will be determined on the pricing date but will not be less than 17.55%, 35.10% and 52.65%, respectively.
- **POTENTIAL EARLY EXIT WITH APPRECIATION AS A RESULT OF AUTOMATIC CALL FEATURE** — While the original term of the notes is just over three years, the notes will be called before maturity if the Index closing level for each of the Indices is at or above the applicable Call Level on a Review Date and you will be entitled to the applicable payment set forth on the cover of this term sheet.
- **LIMITED PROTECTION AGAINST LOSS** — If the notes are not called and none of the Ending Index Levels declines by more than 15% relative to its respective Initial Index Level, you will be entitled to receive the full principal amount of your notes at maturity. If the Ending Index Level for any Index declines by more than 15% relative to its respective Initial Index Level, for every 1% that the Least Performing Index has declined below 15%, you will lose an amount equal to 1.1765% of the principal amount of your notes.
- **POTENTIAL FOR EARLY EXIT AND 17.55%\*\* RETURN IN YEAR ONE, EVEN IF THE INDEX RETURN FOR EACH INDEX IS NEGATIVE ON THE FIRST REVIEW DATE** — The Call Level for the first Review Date is set at 85% of the Initial Index Level for each Index. Accordingly, you will receive a payment of \$1,175.50\*\* per \$1,000 principal amount note after the first Review Date, even if the Index closing level for each Index on the first Review Date reflects a decline of up to 15% from its respective Initial Index Level.  
\*\* The actual percentage and payment if called applicable to the first Review Date will be determined on the pricing date but will not be less than 17.55% and \$1,175.50, respectively.
- **DIVERSIFICATION OF THE INDICES** — The return on the notes at maturity is linked to the Least Performing Index, which will be one of the S&P 500<sup>®</sup> Index, the Dow Jones EURO STOXX 50<sup>®</sup> Index or the Nikkei 225 Index. The S&P 500<sup>®</sup> Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. The Dow Jones EURO STOXX 50<sup>®</sup> Index consists of 50 component stocks of market sector leaders from within the Eurozone. The Dow Jones EURO STOXX 50<sup>®</sup> Index and STOXX<sup>®</sup> are the intellectual property (including registered trademarks) of STOXX Limited, Zurich, Switzerland, and/or Dow Jones & Company, Inc., a Delaware corporation, New York, USA (the “Licensors”), which are used under license. - **CAPITAL GAINS TAX TREATMENT** — You should review carefully the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement no. 95-l. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell, it is reasonable to treat your purchase and ownership of the notes as an “open transaction” for U.S. federal income tax purposes. Assuming this characterization is respected, your gain or loss on the notes should be treated as long-term capital gain or loss if you hold the notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. You should consult your tax adviser regarding the treatment of the notes, including possible alternative characterizations.

## Selected Risk Considerations




An investment in the notes involves significant risks. Investing in the notes is not equivalent to investing directly in the Indices or any of the component stocks of the Indices. These risks are explained in more detail in the “Risk Factors” section of the accompanying product supplement no. 95-I dated August 27, 2007.

- **YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS** — If the notes are not called and the percentage decline of the Ending Index Level of any Index relative to its respective Initial Index Level is greater than 15%, you will lose 1.1765% of your principal amount for every 1% decline in the Ending Index Level of the Least Performing Index relative to its Initial Index Level beyond the 15% buffer.
- **THE RETURN ON THE NOTES AT MATURITY IS LINKED TO THE LEAST PERFORMING INDEX** — You may receive a lower payment at maturity than you would have received if you had invested in the Indices individually, the stocks composing the Indices or contracts related to the Indices or their respective component stocks. An automatic call will be triggered only if all three Indices are at or above their respective Call Levels on one of the Review Dates and, if the notes are not called, your return on the notes at maturity will be determined by reference to the Least Performing Index. Therefore, your investment in the notes may not result in a return on such investment even if the Index closing levels of two of the three Indices are at or above their respective Call Levels on each Review Date. The performances of the three Indices may not be correlated and, as a result, your investment in the notes may only produce a positive return if there is a broad-based rise in the performance of equities across diverse markets during the term of the notes.
- **LIMITED RETURN ON THE NOTES** — Your potential gain on the notes will be limited to the call premium applicable for a Review Date, as set forth on the cover of this term sheet, regardless of the appreciation of the Indices, which may be significant. Because the Index closing level of any Index at various times during the term of the notes could be higher than on the Review Dates and at maturity, you may receive a lower payment if called or at maturity, as the case may be, than you would have if you had invested directly in any, some or all of the Indices.
- **NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS** — As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing the S&P 500<sup>®</sup> Index, the Dow Jones EURO STOXX 50<sup>®</sup> Index or the Nikkei 225 Index would have.
- **CERTAIN BUILT-IN COSTS ARE LIKELY TO ADVERSELY AFFECT THE VALUE OF THE NOTES PRIOR TO MATURITY** — While the payment on any Review Date or at maturity described in this term sheet is based on the full principal amount of your notes, the original issue price of the notes includes the agent’s commission and the cost of hedging our obligations under the notes through one or more of our affiliates. As a result, the price, if any, at which J.P. Morgan Securities Inc., which we refer to as JPMSI, will be willing to purchase notes from you in secondary market transactions, if at all, will likely be lower than the original issue price and any sale prior to the maturity date could result in a substantial loss to you. The notes are not designed to be short-term trading instruments. Accordingly, you should be willing to hold the notes to maturity.
- **NO DIRECT EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES** — The value of your notes will not be adjusted for exchange rate fluctuations between the U.S. dollar and the currencies in which the stocks composing the Dow Jones EURO STOXX 50<sup>®</sup> Index and the Nikkei 225 Index are denominated, although any currency fluctuations could affect the performance of the Dow Jones EURO STOXX 50<sup>®</sup> Index and the Nikkei 225 Index. Therefore, if the applicable currencies appreciate or depreciate relative to the U.S. dollar over the term of the notes, you will not receive any additional payment or incur any reduction in your payment at maturity.
- **LACK OF LIQUIDITY** — The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.
- **POTENTIAL CONFLICTS** — We and our affiliates play a variety of roles in connection with the issuance of the notes, including acting as calculation agent and hedging our obligations under the notes. In performing these duties, the economic interests of the calculation agent and other affiliates of ours are potentially adverse to your interests as an investor in the notes. In addition, we are currently one of the companies that make up the S&P 500<sup>®</sup> Index. We will not have any obligation to consider your interests as a holder of the notes in taking any corporate action that might affect the value of the S&P 500<sup>®</sup> Index and the notes.
- **MANY ECONOMIC AND MARKET FACTORS WILL IMPACT THE VALUE OF THE NOTES** — In addition to the level of the Indices on any day, the value of the notes will be affected by a number of economic and market factors that may either offset or magnify each other, including:
  - the expected volatility in each Index;
  - the time to maturity of the notes;
  - the dividend rate on the common stocks included in each Index;
  - the expected positive or negative correlation between the S&P 500<sup>®</sup> Index, the Dow Jones EURO STOXX 50<sup>®</sup> Index and the Nikkei 225 Index, or the expected absence of any such correlation;
  - interest and yield rates in the market generally;
  - a variety of economic, financial, political, regulatory or judicial events;
  - the exchange rate and the volatility of the exchange rate between the U.S. dollar, the European Union euro and the Japanese yen; and
  - our creditworthiness, including actual or anticipated downgrades in our credit ratings.

The Index closing level of the S&P 500<sup>®</sup> Index on August 29, 2007 was 1463.76. The Index closing level of the Dow Jones EURO STOXX 50<sup>®</sup> Index on August 29, 2007 was 4193.58. The Index closing level of the Nikkei 225 Index on August 29, 2007 was 16012.83.
