



## **Important Information Regarding Quality Distribution Exchange Offer for Outstanding 11.75% Senior Subordinated PIK Notes Due 2013**

TAMPA, Fla., May 3, 2010 (GlobeNewswire via COMTEX News Network) -- Quality Distribution, Inc.
