David Powers elected to board of governors for the University of North Carolina

WINSTON-SALEM, N.C. – April 13, 2011 – Reynolds American Inc. announced today that David M. Powers, vice president of state government relations at RAI Services Company, has been elected to the board of governors for the University of North Carolina. Powers will serve a four-year term on the board beginning in July.

Chartered in 1789, UNC was the first public university in the United States and the only one to graduate students in the eighteenth century.
