Stockholder Meeting Notice

Semtech Corporation's Annual Meeting of Stockholders will be held on June 15, 2017 at Courtyard Marriott, 4994 Verdugo Way, Camarillo, CA 93012, at 11:00 a.m. Pacific Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all nominees, **FOR** Proposals 2, 3 and 5 and **FOR** 1 Year for the frequency of future advisory votes on executive compensation:

1. Election of Directors.
2. Ratification of the appointment of Deloitte & Touche LLP as the Company's independent registered public accounting firm for the 2018 fiscal year.
3. Advisory resolution to approve executive compensation.
4. Advisory vote on frequency of executive compensation votes.
5. Approval of Semtech Corporation 2017 Long-Term Equity Incentive Plan.
