The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
- (On February 23, 2017, 7,023 restricted shares of Mr. Fry's Company stock, earned February 15, 2016, vested. On February 23, 2017, Mr. Fry automatically 2) surrendered 2,579 of the 7,023 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting.
