**Commentary on sales growth, store openings, and headcount growth:**

**Sales growth** - The value of the Canadian dollar relative to the US dollar dropped dramatically during the Fall of 2008. In June 2009 and 2008, the average exchange rate was 0.8885 and 0.9939, respectively. This relative change **lowered our daily sales growth rate by 0.6%** in June 2009. **Store openings** - During our earnings conference call in January 2009 we discussed our limited visibility on sales trends and our thoughts on store openings. Our stated goal is to open 7% to 10% new stores each year; however, we have slowed our store openings to a rate of approximately 2% to 5% for 2009 unless we see some signs of improvement in our sales growth.
